

Note 2: To perform derating ensures the device reliability.

In operation, the collector emitter voltage(V<sub>CES</sub>) should be below 1150 V, as well as junction temperature( $T_j$ ) should be below 140 °C.




Fig. 6.2.1 Test Circuit of Switching Time




Fig. 6.2.3 Test Circuit of Switching Loss




Fig. 6.2.2 Timing Chart of Switching Time




Fig. 6.2.4 Timing Chart of Switching Loss






Fig. 7.1 Marking




